Minutes of Discussions on the Preparatory Survey on the Section between Agro-Industrial Park Site and Route 90 of the Improvement of Outer Bypass in Jericho

The Team held discussions with the officials concerned of PA and conducted a field survey at the study area regarding to the section between Agro-Industrial Park Site and Route 90.

In the course of discussions and field survey, both parties confirmed the main items described in the Attachment.

- I. OBJECTIVE and ARRANGEMENTS of the SURVEY
- 1. Objective of the Survey

The Survey has the following objectives;

- (1) To confirm the contents of the requested Project, discuss with the Palestine side, conduct the site survey and collect the necessary data and information for formulating the Project to meet the conditions of Japan's Cooperation.
- (2) To explain the Japan's Grant Aid scheme to the PA side.
- (3) To report the result of Study to Government of Japan.
- 2. Area of the Survey

The area of the survey is shown in Annex-1.

3. Responsible Ministry

The Responsible Ministry for the survey is the Ministry of Transportation.

- 4. Schedule and Arrangements of the Survey
- 4-1. Consultant members of the Team will proceed to further studies in PA until December 1, 2009.
- 4-2. JICA will prepare a Technical summary as a result of the Survey in English, and send it to the PA around March, 2010.
- 4-3. Regarding to the environmental and social considerations, the PA side will conduct an Initial Environmental Examination (IEE) level survey together with the Team
- 4-4. PA side shall provide necessary numbers of counterpart personnel to the Team during the period of their studies in PA.
- 4-5. PA side shall submit answers to the Questionnaire, which the Team handed to the PA side, by November 12, 2009.


II. JAPAN'S GRANT AID SCHEME

- 1. Japan's Grant Aid Scheme
- 1-1. PA side understands the Japan's Grant Aid Scheme explained by the Team.
- 1-2. PA side will take the necessary measures, as described in Annex-2, for smooth implementation of the Project, as a condition for the Japanese Grant Aid to be implemented.
- 1-3. PA side assured to take the necessary measures to make VAT exemption for all local contracts.
- 2. The JICA Guidelines for Environmental and Social Considerations
- 2-1. The Team explained the outline of the JICA Guidelines for Environmental and Social Considerations (hereinafter referred to as "the JICA Guidelines"), and the PA side agreed to take the JICA Guidelines into consideration.
- 2-2. The PA side agreed to obtain basic agreement from the Project Affected Persons (PAPs) including land owners regarding the Project, and to arrange the budget allocation for land acquisition, resettlement and compensation for PAPs before the approval of the Project by the Government of Japan, in case any PAPs would be identified at the Project sites.

3. Operation & Maintenance

PA side shall secure enough budget and personnel necessary for the operation and maintenance of the roads and facilities improved by the Project, including the periodical maintenance work after the completion of the Project.
